Call to order with the pledge of allegiance at 6:30 PM. Board members present were: Dennis Spencer, Allison Chmielewski, Lee Chard, Lenny Mezey, and Kevin Kaczmarek.

Supervisor called for public comment. None

Minutes: Motioned by Spencer and supported by Chard to approve with one correction Charles from APM should have been Ben... Passed.

Treasurers Report: General Checking \$64,121.95. General Savings \$154,494.13. Total Township Assets \$2,039,379.03. Spencer motioned & Mezey supported to approve as presented. Chmielewski voted nay. Passed.

Fire Department was moved up in the meeting so Kalosis could attend a training session. There were two house fires and downed power lines. There was more discussion on the new truck. Spencer had received offers from the bank on possible finance solutions. (Meredith Shandy-Huntington Bank). We would need to pay \$262,000 upon delivery of the truck. Chmielewski question the continued use of the old pumper truck (#1531) which is reported to be in an unsafe condition. Kalosis will have Circle K come and do an inspection on it. If it fails inspection, it will be immediately taken off the road.

Correspondence was reviewed. The bi-annual audit report was reviewed by the board. The reporting memo is attached to these minutes. The overall position of township finances is excellent. The clerk distributed copies of the MTA booklet on Marihuana regulations as passed by Proposal 1. The matter was tabled for further discussion to give board members the opportunity to review the materials. Several other items were reviewed and distributed.

Old Business: Spencer reviewed bids received from Rustic Rails for the fence repair. The old fence is no longer salvageable and would require complete replacement. Cost for the park would be \$12,300.26. Around the old hall \$2,769.00. Memorial Park \$3,902.17. Cemetery \$254.00. Matter tabled for further discussion. The sheds for the park and cemetery will be delivered and set up in the spring. Total cost will be \$3950.00 of which a \$406 deposit has been paid. Resolution 2018-4 regarding the doubling of fees where a land use permit was not obtained prior to building was re-presented. Motion by Chmielewski and Supported by Spencer. Roll call taken. All ayes.

New Business: Kaczmarek motioned to continue to collect the 1% admin fee on the tax bills. Chard supported. Passed. Spencer motioned and Chard supported to allow Chmielewski to enroll BOR members in MAA class when details arrive. Kaczmarek attempted to offer a salary resolution minus the resolution requesting a 3% pay increase. He was told to re-present it at the February meeting. Chmielewski announced she will be taking one of the old wooden tables out of the old hall to use for box storage at her home. Chmielewski further requested the board look into options for hall expansion or erecting a new township hall since we frequently run out of space in our monthly meetings. Options will be explored. Proud Daughter (Marion Chard) submitted a new contract to continue as webmaster for the township. Spencer moved and Mezey supported. Chard abstained. Passed. Chmielewski motion & Spencer supported to request a streetlight at the corner of Mapleridge & Kindig Rd. Passed

Planning: John Hoffman gave a detailed report on permits issued since he was hired. Mezey reported there will be a planning meeting in March. They will notify Chmielewski so she can swear in members whose terms are expiring.

Parks & Rec: Marion and crew have been hard at work lining up potential donors to the park projects. They have applied for grants and solicited corporate donations for the park improvements. She reviewed the criteria for donations to the Music in the Park. You go Parks & Rec. Great job!

Bills: The board reviewed the bills paid for January. Spencer moved and Chard supported to approve the bills as presented. Passed

Public Comment: Les Barkman asked for some clarification on zoning permits vs. FLPOA permits. It was given. Dave Roberts spoke briefly on MMFLA

There being no further business to come before the board the supervisor adjourned the meeting at 8:02 PM.

Call to order with the pledge of allegiance at 6:30 PM. Board members present were : Dennis Spencer, Allison Chmielewski, Lee Chard, Lenny Mezey and Kevin Kaczmarek.

Supervisor called for public comment. Eichman asked if anything could be done about the tree obstructions at Jackpine & M-76. That is private property and it is unlikely we could do much. Masch had questions about the park and the Halamar money. She was referred to the P&R section of the agenda.

Minutes: Motioned by Spencer and supported by Chard to approve. Passed.

Treasurers Report: General Checking \$81,860.16. General Savings \$149,174.87. Total Township Assets \$1,975,002.28. Spencer motioned & Mezey supported to approve as presented. Chmielewski voted nay. Passed.

Correspondence was reviewed. Several items were reviewed and distributed. Supervisor presented Clerk with revised copy of December BOR minutes. BOR times and dates were reviewed. The board will be meeting with the road commission between March 19-21 at 5PM. Spencer to advise.

Old Business: Recreational marijuana establishments were reviewed. The township has opted to support anew resolution to opt out at least temporarily. Chmielewski reviewed her discussions with Eppert regarding gypsy moth refunds. We can hold back a portion of the money as contingency money for an emergency. Chmielewski will continue to research suppression programs in the area. Blight ordinance 2019-1 has been published as required and was adopted with all ayes. Salary resolutions were presented by Kaczmarek. Spencer, 4 ayes. Chmielewski, nay. Chard, all ayes. Mezey, all ayes. Chmielewski , all ayes. Chmielewski presented salary resolutions that were the same as Kaczmarek except for Spencers. All ayes on Resolutions 2019-3, Resolution 2019-4 and Resolution 2019-5. Chmielewski presented Resolution 2019-2 to limit the treasurers report to financial information only with no editorial comment. All ayes. Chmielewski made a motion to increase mileage to \$.58 per mile (federal rate). Supported by Spencer. Passed.

New Business: The fire hall furnace died unexpectedly and emergency replacement was necessary. Vittitow was contacted and did the emergency installation the next day. He quoted \$4,200 for the furnace and installation but only billed the township for \$4,000. Thank you Ron. Spencer reviewed potential road plans for 2019-2020. ACRC would really like us to do Jackpine Road (\$206,880.00) while it an still be resurfaced. It is an expensive project and will require more study. A portion of South Forest Lake (\$66,334.80) is also in need of resurfacing. Everyone would like to see County Line Road done this year (Motor grader \$15,000 Standard grading \$60,000). Finances will dictate project priorities. We have \$25,000 discretionary fund available to us through ACRC as well as a \$15,000 gravel allowance. Once again we must do our own roadside mowing. Spencer has a lead on a new source for the mowing. Spencer expressed some well thought out ideas for the new fire truck and possible new hall. These will be explored. The Annual meeting will be held on March 30, 2019 at 9AM immediately followed by the Budget hearing.

Planning: John Hoffman presented his usual complete report. Mezey announce the planning meeting will be held on March 5, 2019 at 5PM.

Bills: The paid bills were reviewed. Spencer motioned and Chard supported to approve the bills as paid.

Parks & Rec: Marion and crew presented an alternative to the split rail fencing for the park. It will be reviewed. They currently have 6 grant applications in process. She presented a bid from Kanthe to repair the remaining 3 dugouts at a cost of \$11,250. April 13 will be the Easter Egg Hunt at the hall. The Easter Bunny is ready to go.

Fire Dept: 3 runs (2 mutual aid) and one arcing power line. 1531 is at Circle K for certification. Driven by Kalosis. Spencer is proposing a new, but smaller truck that can be purchased for \$210,000 that is 4 wheel drive and has a back seat. Gas price level does not appear to be a problem.

Public Comment: Tom Spencer felt we should look into the possibility of expanding the kitchen area to accomodate small gatherings. There was more discussion on replacing the old hall with anew one. Alyce likes Spencer's ideas. M. Madigan advised that the Bear Creek corners are in very poor shape. Kalosis reminded everyone that the currently used hall was designed for the fire department and not its current use. Dave Roberts would still like to open a provisioning center (marijuana) and wants board cooperation.

There being no further business to come before the board the supervisor adjourned the meeting at 8:28 PM.

Public comment: Dave- re: revamped master plan and medical marijuana. Tom- brush cutting and ditching crossroad/culvert on Henry. Judd- On Seder, water running over road. Cost study? Marge-commented on same. Matt- reported light out on flagpole. Had zoning question but John Hoffman is out sick. Manny- building permit question. This is through the Arenac County Building Dept. Land Use Permit via John Hoffman.

Minutes: Motioned by Dennis and supported by Lenny to approve minutes as presented. All ayes.

Treasurers Report: General Checking \$73,259.29, General Savings \$175,148.08, Total Township Assets \$2,413,402.82. Dennis motioned & Lee supported to approve as presented. All ayes.

Correspondence reviewed. Letter from State Treasury Dept. Not pertinent to this board.

Unfinished Business: 2019-6 opt-out form, tabled for one month. Dennis stated that Allison was in touch with Twp attorney regarding gypsy moth fund. Rick Rockwell submitted copy of millage proposal on Sims Twp ballot to move money from one fund to another (in their case mosquito control). Could we do something similar, moving gypsy moth fund to a building fund, (for example)? Dennis will be attending road commission meeting on Wed, so no discussion tonight. However, we received quote from AuSable Services in regards to mowing ditches in our township.

New Business: Discussed preliminary budget review. Meeting at end of month. Tom Spencer presented cyber security news. Gave handout to the board and the public. He stated that Kevin and Allison's computers were in good shape with no vulnerabilities. Solar farms briefly discussed, however, will wait until Allison is present.

Planning: John Hoffman absent. Lenny stated that language needed for ordinance regarding solar farms.

Zoning Board of Appeals: Lenny stepped down. Lee took his place. New board consists of Lee Chard, Brian Peariso, and Marian Seder. Motioned by Dennis, seconded by Lenny. All ayes.

Bills: Tabled for this evening.

Public Comment: Tom Spencer questions some current procedures/invoices within the fire dept. Stated that standards should be set regarding these and related matters. Motion regarding DOT/structural matters proposed by Dennis and seconded by Kevin. All ayes. John brought up cost study again. Stef reminded us of Easter egg hunt on April 13<sup>th</sup> at 1pm. Rick K stated that one member of Twp board should deal with questions/concerns regarding fire dept., and Dennis volunteered. Gail expressed concerns regarding fire dept. invoices. Dave discussed marijuana concerns for the twp. Kevin K agreed that some issues were confusing. Susan suggested that those matters should be fielded by a sub-committee.

Old Business: Recreational marijuana establishments were reviewed. The township has opted to support anew resolution to opt out at least temporarily. Planning: John Hoffman presented his usual complete report. Mezey announce the planning meeting will be held on June 13, 2019 at 5PM.

Bills: The paid bills were reviewed. Spencer motioned and Mezey supported to approve the bills as paid.

Parks & Rec: The septic system should be started shortly. The sheds are ready to be placed. Swanson will be doing the demo work in the cemetery. Ok to pay balance on sheds. A grant from the Bay-Arenac Foundation was discussed. 76 youngsters attended the Easter Egg Hunt. Great Success.

Fire Dept: 5 runs (1 mutual aid) (2grass fires) and one arcing power line. There was one water rescue requested but it was for a wild animal. The fire dept has applied for an \$8400.00 grant to purchase extraction tools.

Jedi presented the board with the election results from the Fire Fighters Annual Meeting. Pat Jedi, President, Mark Thurlow, VP, Tom Spencer, Treasurer and S. Kernstock, secretary.

Public Comment: G. Schoenherr question the process for zoning appeals. Roth questioned damage to Wilderness Dr. Roberts again questioned MM. Spencer said mowing would cost \$37.00 per mile this year for 2 mowings.

Supervisor called for public comment. Roberts has established a pig farm on his property on Mapleridge Rd. He and Masch expressed the opinion that this was a great addition to the township. It is unclear whether there will be further discussion on this issue. It is clear that this falls outside the zoning ordinance for approved uses. Haiser raised the issue of Bear Creek Road. Spencer is requesting bids for the project.

Special discussion: Judy Bell and Adam Krocaleski spoke about the continuation of the GIS (Geographical Information System) for the county. They are looking to establish an authority comprised of all the townships, villages, and cities in Arenac County. Each unit would contribute .80 per parcel in their unit. The county would contribute .20 per parcel. Each unit would be eligible for a position on the authority. Tabled for further study.

Minutes: Regular Meeting motioned by Spencer and supported by Chard to approve. Passed. Special Meeting motion by Spencer supported by Chard. Passed.

Treasurers Report: General Checking \$38,899.08 General Savings \$183,059.27. Total Township Assets \$1,959,732.93. Spencer motioned & Chard supported to approve as presented. Chmielewski voted nay. Passed.

Correspondence was reviewed. Several items were reviewed and distributed. P&R has been awarded a \$5000.00 grant from Bay-Arenac Foundation towards new bathrooms. M. Chard was congratulated.

Old Business: Recreational marijuana establishments were reviewed. Spencer motioned and Mezey supported to opt out at least temporarily. After telling the board that our funds were fully insured by Huntington and being asked to provide proof of said coverage, the treasurer announced our funds were not insured over the \$250,000 FDIC limit. He now seeks board approval to move the funds to another account that he states insured to an unlimited amount at a 2.8% APY. He needs to provide the board with written proof of this contention and the accountants will need to be consulted before such action is taken. There was more discussion on the gypsy moth issue. This has been confirmed by both the township attorney and the MTA. We can (per attorney Eppert) withhold funds for a contingency use on gypsy moth only.

The spring cleanup was discussed. L. Chard to seek bids for 3 dumpsters. Dennis announced that the fire truck is being delayed due to the absence of an available chassis. The motion to approve the bid for brining was increased from \$11,000 to \$12,000.

New Business: Fire point pay was discussed. Further discussion on "Michigan class fund". Again, Kaczmarek needs to provide paperwork. Kaczmarek wants to collect NSF fees. He needs to look into that. (A committee to be known as the "Moffatt Marijuana committee" was formed to include Mezey, D. Roberts, J. Hoffman, and Pat Jedi.) The tax reverted properties were reviewed Spencer motioned and Chard supported to relinquish any claim to the properties.

Planning: John Hoffman presented his usual complete report. Some discussion on setbacks and storage containers. Also, does the Pig farm require a variance. The Planning commission will need to provide guidance. Mezey announced the planning meeting will be held on Thursday, June 13, 2019 at 5PM.

Bills: The paid bills were reviewed. Spencer motioned and Chard supported to approve the bills as paid. Passed

Parks & Rec: As always, hard at work.

Fire Dept: One downed power line and a couple of other runs.

Public Comment: Chmielewski announced that Pro Scape had advised that the cemetery would be ship shape for Memorial Day. Also, the flags are in and the Sterling Boy Scout troop #188 will again be placing the flags on all veteran graves. Sue Masch asked if there was a minimum age for addressing the board. delayed due to weather. Still looking for an electrician to do repairs in the park. Hoffman will contact his son-in-law. Swanson's has been contacted regarding the installation of the septic field.

Fire Dept: Did not receive a grant this time around. Two mutual aid runs. Still no truck chassis available. The drone owned by Arenac County crashed unexpectedly.

Public Comment: Deb W. asked if we could get a microphone for Chmielewski while her voice is out. Oertel reported there are two trail cameras in the cemetery. Jedi to follow up. Barkman asked about the fire truck chassis. It is a Ford F550. Tim Spencer was disappointed that the road commission over bladed Henry Road resulting in a concave surface.
