SPECIAL MEETING

At Moffatt Twp Fire Dept

May 3<sup>rd</sup>, 2022 @ 5:30pm

Supervisor called meeting to order at 5:30pm with Pledge.

Board members: Ray, Stefanie, Lenny, Kevin & Lee. Zoning Administer -John S. Huges, T. Huges, B. Roth, D. spencer, T. Spencer, L. Marx, Jeff & Joyce Kohoyda, A. Oertel.

Ray started discussion on roads- where to pave as we need orders of much paving we are doing in asap. Kohoyda asked about the culvert being clogged on Maple Ridge between Henry and Kindig. Huges brought up that Forest Lake board is not going to log common grounds of Wilderness now, so please pave Wilderness. Bill Roth on Forest Lake board of directors confirmed that there's no longer talk of logging on Wilderness. Twp board asked if Forest Lake will put this writing along with a time frame not logging for 10 years to protect the road from damage of the log trucks. With this information Kevin motioned to pave Wilderness from Pineview to Wildwood with the contingency of the Letter from Forest Lake Property Owners of not logging for 10 years on Wilderness, Lee supported. carried. Lenny motioned and Kevin supported Seder Road 600 feet of gravel and ditching with replacement of (1) driveway culvert due to being taking out during ditching. Carried. Lee motioned and Ray supported paving 600 ft on N. Forest Lake by Bob White. Carried.

Resident had paid for building permits from previous Twp Building Permit Contractor years ago and now Arenac County Building Department handles the permits. The old contractor is no longer around. Resident needs final ok from building inspector, Resident needs new building permit now. Stefanie motioned to pay the \$80 permit fee to the county for the permit. Lee supported. carried.

Procom Bills from 11-26-19 and 7-23-20 were never paid, from previous clerk and took some sorting out. Kevin motioned and Lee supported to pay bills. Carried.

Dog Park Fence had a 10-day quote price. Quote is \$14,800 includes fencing, gates and work. Ray motioned no support. Motion did not carry.

Park Rental form update. Updates discussed and agreed

Dump day- junk is all over twp. on roads, twp. will pick up for dump day. Please stop dumping on the roads.

Cemetery dumpster is coming please do not throw old arrangements along the fence.

Possibility of looking into Hanks to purchase as new Twp Hall. Old hall status?

Residents very upset about property next to fire hall due to severe blight. Discussion. Zoning administer said he has given several written letters and been working to get property cleaned for a couple years. Last letter was a 30-day notice on 4-12-22.

Supervisor spoke of possibility paying board members special meeting pay.
